DECLARED that:


1. The Commonwealth of Virginia is currently under Phase Three of the Governor's reopening plan; and

The Clerk of Court is directed to send a copy of this order to all counsel of record.


Nothing further having come before the court,

This matter is ended, and the complaint is DISMISSED. Each party is to bear its own costs.


